Manitoba chiropractors are experts specifically trained to diagnose the underlying cause and recommend treatment options relating to the spine, musculoskeletal and nervous systems.

Chiropractors are trained to relieve pain, restore mobility, increase function, and prevent re-occurrence so Manitobans can get back to leading healthy, active lives.

Chiropractors are also trained to provide advice to patients on activities of daily living, work, healthy lifestyle choices, injury prevention and nutrition.

On other fronts, members were offered the opportunity to become part of the immunization team in March. A number of our members participated in the training process providing an example of the power of interprofessional collaboration.

The other significant change for the MCA in 2021 was finalizing our new home at the Clarion Hotel. The new office will allow our Association to move forward in a professional and positive way. There is ample space for Board and Committee meetings and a professional workspace for our staff. We look forward to welcoming members to the new office at our earliest opportunity.

There has also been a considerable amount of work undertaken in the past year that, while not glamorous, was integral to the operations of the MCA. The Board worked diligently to strengthen our governance, reviewing and revising policies, creating terms of reference and reviewing standards of practice to ensure we are operating in the best possible manner on behalf of our membership.

I feel privileged to have served this past year as your President. I greatly appreciate the wise counsel and strong commitment of our Board and staff and the support of our membership. We have a lot of work to do in the coming year and I'm confident that, with the guidance of our Strategic Plan, we will continue to advance our profession.

The 5-year plan for the MCA that was approved by the Board, provides a clear roadmap for the profession.

The early results of the campaign are promising and the uptake on this campaign continues to increase.

Our basement was full of cabinets of historical files and these are now all digitally preserved. #### **INCORPORATION STATISTICS**

On November 8, 2018 new legislation was passed allowing for professional incorporation. Since that date, the MCA has issued 54 Chiropractic Corporation permits.

# REGISTRAR'S REPORT DR. AUDREY TOTH, D.C., CAFCI



In 2021, the pandemic persisted with waves of variants which challenged our profession and its Regulatory Body. The MCA Regulatory Body served to assist in the mandate to ensure public safety, ensure that our members were advised of changes in public health orders, supported, and redirected to the benefit of the public we serve. This is an ongoing process. As I reflect on the last year, the MCA continued in diligent work with the regulatory authority to conduct member office "spot checks" to ensure that chiropractors in Manitoba followed the Public Health Orders relating to the pandemic. In the 2020 Annual Report, I shared the comment that I had heard that being a regulator during COVID-19 has been like "trying to build a plane while you are flying in it." The comment this year is that 2021 has been like "trying to land that plane on a runway while the runway is being built." Appreciation is expressed for the cooperation, understanding and professionalism repeatedly encountered by so many colleagues in Manitoba during these uncertain times. I remain honored to have been a support to our members during particularly unique and oftentimes stressful situations. Our profession can be proud of a membership that has adapted and thrived in practice during a pandemic. Our membership has learned a way to ethically manage the "new normal" for this profession and have asked appropriate questions and sought clarity when uncertainty arose.

On the licensing front, there is notably less of an impactful backlog of candidates awaiting completion of National Board Exams than was reported in the previous year. The MCA continues to receive applications for licensure and registration and welcomes our new members to Manitoba. In Spring of 2021, the MCA had just obtained license and subscription to the automated WebScraper Tool program in direct response to the increase noted in member vs. member complaints in 2020 (particularly those pertaining to advertising on websites and social media). In 2021, it was calculated that there was more than a 55% reduction in member vs member complaints and of the eight (8) complaints which were filed with the MCA in 2021 by other members, five (5) specifically related to advertising concerns and were filed prior to the implementation of the WebScraper. With the advent of WebScraper and the latitude to consider context of content. the member vs member complaints specific to advertising ceased. After a full year of use with the WebScraper Tool the Registrar is pleased to share that of all the content flagged from a lengthy list of key words and phrases, only 6% was deemed of content which could be construed as potentially non-compliant to legislation and with regulatory risk. Generally, MCA members upon hearing that there is an issue are open and amenable to remove or amend the content in question. If a member disagrees with a WebScraper notification, the regulatory process remains in place as an available avenue to address the issue.

Lastly, I highlight the team efforts of the MCA staff and the MCA Board of Directors for their work and consideration. It is a pleasure to be a part of the regulatory team that is steering the MCA in the right direction. The MCA Registrar has regular office hours. 


