- Monitoring and evaluating professional Standards of Practice;
- Investigating complaints and initiating disciplinary proceedings, when necessary;
- Establishing a continuing professional competency program for all members.

The MCA networks with many other professional associations, regulatory organizations and government which helps position chiropractors as valuable contributors in Manitoba's integrated health care system.

Self-regulation is a privilege granted in the public interest and for the public good. The MCA is committed to governing in a manner that respects this privilege.

ABOUT CHIROPRACTIC CARE

Manitoba chiropractors are experts specifically trained to diagnose the underlying cause and recommend treatment options relating to the spine, musculoskeletal and nervous systems.

Chiropractors are trained to relieve pain, restore mobility, increase function, and prevent re-occurrence so Manitobans can get back to leading healthy, active lives.

Chiropractors are also trained to provide advice to patients on activities of daily living, work, healthy lifestyle choices, injury prevention and nutrition.

PRESIDENT'S MESSAGE

In reflecting on this past year, I am extremely proud of the work the MCA Board and management has been able to accomplish. We remain committed to our current strategic plan which was created to guide the work of the MCA Board and management team through 2026. It was developed through a collaborative process that included consultation with a cross section of MCA members, representing the various demographics of our membership. The plan has three major goals which are listed below along with some highlights from the last year showcasing the work done in support of these elements and therefore our membership:

Increase annual utilization to 20%

The MCA's advertising and promotion campaign is a cornerstone activity under this tenet. Over the last year we've updated our website, relaunched our social media presence, completed a public research survey, expanded our advertising activities as well as our communications to members and laid the groundwork for patient testimonials and a chiropractic informational video series. Through a collaborative process the MCA and MPI were able to negotiate a contract that will secure the benefit of Chiropractic care for Manitobans injured in an MVA. We are actively doing the same with WCB.

Unify the membership

With the relaxing of restrictions, the MCA was able to bring its members together for the first time since the onset of the pandemic. We convened members to provide opportunities for expanding and strengthening relationships at events such as our Charity Golf Tournament, a professional development seminar on the Thompson Technique and capping off 2022 as sponsors of the Manitoba Chamber of Commerce's Holiday Reception. We got right back at it in January 2023 with the MCA hosting a professional development day in collaboration with MPI.

Successfully transition under the RHPA

We also recognize that the MCA will be a different organization in the future. We are moving in that direction as we're able and in alignment with the government's timelines. We communicate regularly with government on the RHPA and other opportunities as they arise.

In addition to the above there was a focus on enriching our relationships on the National level. The MCA attended the leadership summit hosted by the CCA in addition to the Annual meeting of the Federation of Chiropractic Colleges.

While the above highlights the advocacy work of the MCA, our role as a regulatory body remained our primary focus. Ensuring the safety of the public is our most important responsibility and remained at the forefront of our activities. Managing this responsibility to the profession and public is one we continue to undertake with a commitment to transparency, reasonableness and efficiency.

EXECUTIVE DIRECTOR'S MESSAGE

The past year has been an active one for the Manitoba Chiropractors Association. Using the strategic plan as a roadmap, activities around increased utilization focused on the key strategy of expanding outreach and influence. The first step in this was to understand and benchmark public perceptions of the profession which not only informed our advertising activities, but our government, stakeholder and community relations as well.

Growing awareness and the profile of the profession meant reminding, or in some cases educating, Manitobans that chiropractors are not only healthcare professionals, many are also entrepreneurs and small business owners. With this approach the MCA had conversations across government departments and into the broader business community. Some notable events included Mayor Brian Bowman's office lighting the Winnipeg Sign at The Forks in support of World Spine Day 2022. Minister of Health, Audrey Gordon also proclaimed October 16, 2022 as World Spine Day in Manitoba. MCA staff and members engaged members of all provincial political parties in conversation and outreach events culminated with the MCA engaging industry and government leaders as a sponsor at this year's Manitoba Chamber of Commerce Holiday Reception.

While we worked externally in service to members, we also invested significant time and energy in operational improvements at the MCA. We increased communications to members with the creation of our Talking Back Newsletter. A review of technology and processes allowed the MCA to reduce our investment in external contractors while also right sizing our internal staffing allocations. This move alone generated annual savings of over \$100,000. This year also had staff looking at further modernizing member tools with the imminent launch of a refreshed member portal. Work in 2022 was also undertaken with the intention to modernize our member interactions through the implementation of online renewals and other efficiency measures.

I want to thank the Board of Directors and members for the opportunity to serve the MCA over the past year. I'd also like to acknowledge the efforts of all MCA staff for all of their efforts, especially as we've made changes in support of financial and operational enhancements.

REGISTRAR'S REPORT

DR. AUDREY TOTH, D.C., CAFCI



The MCA's Regulatory Role is to promote the safe and ethical delivery of quality chiropractic care in Manitoba. This is achieved by following the framework set out in the Chiropractic Act of Manitoba, C.C.S.M. c. C100 and also through the processes and policies set by the MCA Board. Our responsibility to protect the public means every MCA member, regardless of membership category, shares the responsibility of self-governance and ensuring that appropriate standards of clinical practice and ethical conduct are followed.

MCA carries out the goal to protect the public through three core functions:

- **Registration (Licensing Committee)** ensures that everyone registered to practice chiropractic in Manitoba is competent to practice and meets all the established registration requirements.
- **Quality (Standards Committee)** supervises the competency of practice and proactively promotes safe care for Manitobans.
- **Complaints and Investigations** responds to concerns regarding members' conduct or care and investigates complaints about MCA members.

Leadership for Quality Care

As a member of the Federation of Canadian Chiropractic (FCC), the MCA is involved in chiropractic issues nationwide. As a member of the Manitoba Alliance of Health Regulatory Colleges (MAHRC), MCA plays an active role in provincial healthcare while participating in interdisciplinary initiatives around patient safety and quality care.

Through MAHRC, MCA co-funded a Health Equity Jurisprudence Module. This on-line resource is available to all MCA Members on the MCA Portal. This was done to engage members around *Truth and Reconciliation* in a meaningful way. As a profession, we need to take some time to respect the position of people who have been harmed.

Regulatory Review

The MCA provides leadership by proactively engaging members in quality improvement programs such as office inspections and clinical file audits. This year MCA observed a dramatic drop in member vs member complaints with the implementation of the "WebScraper" program, which monitors online marketing content of MCA members. MCA members identified by the "WebScraper" application and Board directed protocol are expected to give prompt attention to the issue and bring their on-line content within compliance.

It remains my honor to serve as MCA Registrar. If unable to provide immediate support on regulatory matters, the Registrar can direct matters for appropriate consideration. The MCA Registrar has regular office hours and can be reached at registrar@mbchiro.org with any regulatory concerns.


